GSDCA Membership Code of Conduct

This Code is established in accordance with the objectives of the GSDCA to protect and advance the interests of German Shepherd Dogs.

Each member will be familiar with the GSD standard as approved by the GSDCA and The American Kennel Club.

Each member agrees to abide by the GSDCA by-laws, the GSDCA Membership Code of Conduct, the Rules and regulations of the American Kennel Club.

All members will conduct themselves at all times in such a manner as to reflect credit on the sport of purebred dog showing and German Shepherd Dogs in particular. This includes respect for the show site and all other aspects of responsible dog ownership.

Member's dogs will be an asset to their community.

No GSD will be sold to wholesalers or retail stores for the purpose of resale. No GSD will be sold, leased, or offered at stud to franchised commercial facilities, businesses, or agents thereof. No GSD will be sold or donated to a research laboratory or offered as a prize or sold at auction.

Members who contemplate breeding a litter, or who allow the use of their stud dog to the same end, will direct their efforts toward producing dogs of exceptional quality, temperament, and condition and should sign the GSDCA Breeder's Code of Ethics.

A Memorial Day Salute: Our Military Working Dogs

In honor of Memorial Day, I would like to pay tribute to some very special heroes—the U.S military working dogs. I am a sucker for a good dog story and this is the story of thousands of good dogs!

A Few Notable Combat Canines

Dogs in the military are nothing new. They have been around for a lot longer than even the holiday of Memorial Day! In the United States, military dogs date back to the Seminole Wars of 1855, and during the Civil War, American Pit Bull Terriers were used to send messages, to guard prisoners and also for companionship. Even General Custer took a companion dog to war with him. By WWI, the role of dogs in the military became more official, and by WWII, dogs were trained for active duty. They weren't military afterthoughts, they were full-fledged soldiers!

Sergeant Stubby, a Pit Bull mix, was the most decorated combat dog of WWI. He was also the only dog to be promoted to sergeant through combat. Stubby served for eighteen months and participated in seventeen battles on the Western Front. He even discovered and captured a German spy!

During WWII, the U.S. Marine Corps used dogs, which had been donated by their American owners, to recapture territory from Japanese occupying forces in the Pacific Theater. Chips, a German Shepherd mix was the most decorated dog of WWII. In one day, he attacked a small fort, received wounds to the head, forced the surrender of four Italian soldiers and later assisted in the capture of ten prisoners. He was awarded the Silver Star, Distinguished Service Cross and Purple Heart, although they were later revoked, due to an Army policy preventing official commendation of animals.

More recently, U.S. Navy SEALs used Cairo, a Belgian Malinois, in Operation Neptune Spear. You might know that operation better as "the one that took down Osama bin Laden."

In 2012, the American Humane Association awarded Gabe, a specialized explosives search dog, the Hero Dog of the Year Award. Gabe is a yellow Labrador that was deployed in Iraq for thirteen months. During that time, he completed 210 combat missions, which resulted in twenty-six finds and an untold number of saved lives.

The individual stories could go on and on and each one is worthy of telling.

At any given time, approximately 500 military working dogs are deployed. The vast majority will never make the evening news and they ask for no more than a pat on the head for a job well done. So, for that, they deserve our thanks, on this Memorial Day, and every day.





G.S.D.C. OF CENTRAL OHIO, INC. MEMBERSHIP MEETING WEDNESDAY, MARCH 18, 2015

The meeting was called to order at Iacono's Restaurant by president John Ayotte at 7:30 p.m. There were twelve members present.

Minutes of the January membership and February board meetings were read. Teri Ayotte moved the minutes be approved as read, seconded by Joe LaRosa. Motion passed.

<u>Treasurer's Report:</u> Sue Clark gave her report. There was a deficit of \$758.10. There is no income for this period. Charlotte LaRosa moved the treasurer's report be approved, seconded by Kathi Jo Zornes. The report was approved.

<u>Secretary's Report:</u> The list of judges from the February board meeting was sent to all members with invitation for more nominees. Prospective members were given meeting notice and information about training. Ballots to vote for judges for 2016 specialties and futurity/maturity are prepared for the meeting. Received entry form and premium simple text copy from Kathi Jo Zornes. Formatted it for snail mail and e-mail. Copy is prepared for Sue along with labels for mailing. If everything looks in order, will begin sending e-mail to exhibitors and regional clubs. There is an updated mailing list for Kathi Jo and information from AKC website confirming correct information. E-mail inquiry was sent to the parent club secretary requesting whom we contact to obtain bronze medals for shows.

<u>Show:</u> Teri Ayotte reported that prizes have been chosen for the shows. Kathi Jo Zornes is adding additional prizes for puppy classes. Kathi Jo prepared premium list and entry form for shows.

<u>Newsletter</u>: Kathi Jo reported that the newsletter was sent by e-mail today. Hard copy of newsletter will be mailed.

<u>Membership</u>: Marcy Wright reported Joyce Willis may rejoin club. She can do so without penalty by paying annual dues. Marcy is also encouraging a friend active in agility to join.

<u>Unfinished Business:</u> The list of judges for futurity show and specialties for 2016 was presented. Charlotte LaRosa commented briefly on each one. This year all entries in the futurities are down, so we should select strong candidates and consider expenses.

New Business: The matter of offering obedience classes was brought up. Annette Severance was asked if she would be able to conduct classes. She agreed and suggested offering 6 - 7 weeks of beginner novice obedience classes. A Canine Good Citizen test will be given on the last week. Prospective dates are Tuesdays - April 7 to May 12 at 7:00 p.m. Sue Clark is to contact Tim Shade on use of the Ganyard Building. Ads will be placed in suburban papers. There was a discussion of how much to charge. Based on what is being charged in this area, it was agreed to charge \$75. This is public outreach and education so meets criteria by AKC for show giving clubs.

<u>President's Report:</u> John Ayotte said he decided against participating in Pet Expo event. Expense and few being able to help were deciding factors. With more time to plan, we might reconsider next year. He spoke with Jennifer Crank about holding an agility match to qualify to hold agility trials, but no details have been worked out. Marcy Wright will follow up.

There was discussion on where to hold April 15, board meeting. Decision was Iacono's Restaurant. The next membership meeting will be Wednesday, May 20.

Joe LaRosa moved the meeting adjourn, seconded by Kathi Jo Zornes. Meeting adjourned at 8:45 p.m.

G.S.D.C. OF CENTRAL OHIO, INC. BOARD MEETING WEDNESDAY, APRIL 15, 2015

The meeting was called to order at 7:42 p.m. by president John Ayotte. All officers and board were present.

Minutes of the March board meeting were read. Kathi Jo Zornes moved the minutes be approved, seconded by Teri Ayotte. Minutes were approved.

<u>Treasurer's Report:</u> Sue Clark reported there was a loss for the period. We had income of \$270, but show related expenses created a deficit. Teri Ayotte moved the report be accepted, seconded by Joe LaRosa. The motion passed.

<u>Show:</u> Teri Ayotte reported we have our trophies. Sue has ordered ribbons from R.B. Powers Company in Ashley as they are less expensive than Reiser. They requested a picture of our logo to make a die for the ribbons (one-time setup charge). Sue asked how many select ribbons to order. We need four--one for a special of each sex for two shows. John Ayotte is doing the pictures for the GSDC Of Greater Cincinnati, and that will delay his being available for ring setup Saturday afternoon. Kathi Jo has created a Gmail account to keep addresses of exhibitors. John Ayotte said he is considering options of how we might be able to do online entries in 2016.

<u>Newsletter:</u> Kathi Jo reported the spring newsletter hard copy was mailed to members without internet and to the parent club for the newsletter competition. The next newsletter will come out in June after our shows so results can be published.

<u>Membership:</u> Joyce Willis and Denise Fox wish to rejoin the club. Also Sarah Morgan, who previously belonged before moving to another area is interested in rejoining. Since we have a precedent of former members being accepted by payment of dues they were accepted into membership.

<u>New Business:</u> Kathi Jo Zornes reported that AKC is creating a new Canine Good Citizen title. It is Urban CGC in which dogs are tested on dealing with urban issues such as elevators, escalators, traffic and other distractions.

<u>Report Of The President:</u> John requested secretary to look into changes made by AKC allowing specialty clubs to hold more than two shows--specifically how much time is required between events. It was noted that Fort Wayne specialty club no longer holds its shows in September. He requested the secretary send premium lists to our judges.

Secretary's Report: Information was received from AKC regarding updated obedience regulations and forwarded to Kathi Jo for newsletter. Called six judges in order of preference regarding willingness to have names submitted to parent club for 2016 futurity. Libby Cameron declined. Contacted Kathy Potter requesting paperwork for futurity and was informed that would be sent once entries are processed for 2015 futurities. She also informed us that now only three judges have to be submitted. Contacted Jerry Guzman about judging one of our 2016 specialty shows. After checking his calendar, he accepted assignment of morning specialty. He was mailed a contract. Phone call was made to Dave Rinke and left a message. No response at this time. John Ayotte reported that The Cincinnati Kennel Club all breed show's premium (on May 24) listed German shepherd dog breed classes. Phone calls and e-mails were exchanged with AKC, and they corrected the problem and informed Cincinnati Kennel Club they cannot hold breed classes for German shepherd dogs as long as we maintain our date. When Sue was unable to obtain a certificate of mailing from the post office to submit to AKC, placed a call to AKC and was instructed we could send a PDF copy of our premium list and entry form to them. Asked Doug Crane for flight information and received copy of receipt for airline ticket, flight number, and arrival time; that was forwarded to Sue.

Decision on where to hold the May membership meeting was discussed. Iacono's is convenient for most, so meeting will be there on May 20.

Kathi Jo Zornes moved the meeting adjourn. The meeting was adjourned at 8:15 p.m.





April 2015 Board Meeting

New "Urban" CGC Title Added to Canine Good Citizen Program

Giving responsible owners a whole new level of achievement for their dogs, the American Kennel Club (AKC) announced today the launch of "AKC Urban CGC" to the Canine Good Citizen (CGC) training program. The new title focuses on city-dwelling dogs and the special skills they require.

Since 1989, more than 700,000 dogs and their owners have been recognized by the CGC program, which rewards the dogs' good manners at home and in the community. As with CGC, AKC Urban CGC requires a 10-step test of skills that dogs must pass to earn the official AKC Urban CGC title. AKC Urban CGC skills dogs must possess include:

- * Exits/enters doorways (of dog friendly buildings) with no pulling
- * Walks through a crowd on a busy urban sidewalk
- * Reacts appropriately to city distractions (horns, sirens, etc.)
- * Waits on leash, crosses street under control
- * Ignores food and food containers on sidewalk
- * Person approaches on sidewalk and pets dog
- * 3-minute down-stay in lobby of dog friendly building
- * Safely negotiates stairs and elevators
- * Housetrained
- * Enters, exits, rides dog-friendly transportation (car, subway in a carry bag, cab)

"City dogs require a very special set of skills, including waiting to cross a street, ignoring food tossed on a sidewalk, behaving in building lobbies and riding elevators," said Mary Burch, Ph.D., Director of the Canine Good Citizen program. "Urban CGC reinforces practical, everyday skills for the millions of dogs living in urban areas today, creating safer, more responsible communities."

To be eligible for the AKC Urban CGC title, dogs must have a CGC certificate or title on record at AKC and must have an AKC number (AKC registration number, PAL number, or AKC Canine Partners number). Dogs passing the AKC Urban Dog test will earn the "CGCU" title.

With the introduction of AKC Urban CGC, the AKC's CGC program now provides a variety of training options for dog owners and their dogs. Beginning with AKC S.T.A.R. Puppy, progressing to Canine Good Citizen, AKC Community Canine and now AKC Urban CGC, the CGC program trains dogs through all stages of life and in all settings to be well-behaved in society.

Instructors can learn more about the program and begin training their students on AKC Urban CGC skills by visiting the AKC Urban CGC page. Urban CGC test materials are now available in the AKC store. AKC Urban CGC testing will be administered by approved AKC CGC evaluators nationwide beginning this month.

Continuing Education: Club Members Take Pet First Aid & CPR Course

German Shepherd Dog Club of Central Ohio club members Kathi Jo Zornes and Brandon Zornes attended the Jackson Emergency Medical Response Group's Pet First Aid and CPR Certification Course on Wednesday April 22, 2015 at the Ohio State University Extension Office in Jackson, Ohio. The course was taught by Jackson EMS Team Member Lori Simpleton who has served a number of years as a vet tech for Shawnee Animal Clinic & Wheelersburg Animal Hospitals as well as took college courses ideal for veterinarians. The dog used for live demos and practice is active registered therapy dog Jazz, a black Labradoodle TDI certified by Kathi Jo Zornes in 2013.

The group of 14 that took the course consisted of dog club members, groomers, EMTs, humane society officers, and caring pet owners.

The course consisted of several parts covering field techniques for making muzzles, how to properly carry an injured dog, putting together a first aid kit, coming up with a disaster response kit for your dog in the case of an emergency, normal vital signs for dogs and cats, how to give proper CPR to a dog and cat, handling and other useful information. A more comprehensive book on Pet First Aid and CPR was provided for purchase at \$16 a copy. The course was concluded with a test. Everyone who passed the test received a Pet First Aid & CPR certification card.

As our Club's AKC Show Secretary, Kathi Jo felt this a worthwhile and necessary education in light of the dog shows our club hosts annually. While we would certainly hope that there'd be no accidents, our Club will now have people educated in Pet First Aid & CPR present on our show site during our AKC shows this year!



NEWS For Health: New Canine Flu Virus H3N2 Strain is Hitting the Midwest

The Midwest Canine Influenza outbreak is known to be caused by a new strain of the infuenza virus. A week ago, initial tests at the Wisconsin Veterinary Diagnostic Laboratory (WVDL) and Cornell University identified the strain as H₃N₂, which has previously only been seen in Asia and is different than the H₃N₈ strain that has been been circulating in North America since 2004.

The commercially available vaccines for CIV (Canine Infuenza Virus) are made to protect against the H₃N8 strain, and their effectiveness against the H₃N2 strain is unknown at this time, however there are no signs that it is effective. At this time, we are not recommending the CIV vaccine but we will have it available if you wish to vaccinate your pet.

At this time, we are also recommending the following:

Limit direct dog-to-dog contact. This is especially important with unknown dogs and any dogs displaying clinical signs, including cough, running nose and fever. If your dog shows any of these signs, contact your veterinarian and do not take your dog to a boarding facility, dog daycare, dog park or other public place.

The virus will live in the environment for 24 - 48 hours in the majority of the cases, but washing with soap and water is very effective at inactivating influenza virus. Wash your hands and change your clothes if you work with or are exposed to sick dogs before handling your own pets at home.

Both Influenza strains (H₃N₂ and H₃N₈) can cause the following symptoms:

- -Dry hacking cough
- -Coughing up a white foamy phlegm
- -Lethargy
- -Vomiting
- -Lack of appetite
- -Nasal discharge
- -Fever
- -Rapid breathing

If your pet is exhibiting any of these signs, please contact your veterinarian's office.


