**G.S.D.C. OF CENTRAL OHIO, INC. MEMBERSHIP MEETING  
WEDNESDAY, SEPTEMBER 16, 2015**

President John Ayotte called the meeting to order at Iacono's Restaurant at 7:43 p.m. There were twelve members present. Minutes were published in the newsletter, and Charlotte LaRosa moved the reading of minutes be dispensed with.

Treasurer's Report: Sue Clark reported there were no changes from last report. Audit of books will be scheduled before the October board meeting.

Secretary's Report: Parent club was contacted on August 13 to approve our May 29, 2016, specialty shows. Joy Schultz sent message that approval was faxed to AKC. AKC approval of shows was received on August 18. Electronic submission of membership list as required by AKC was sent on September 8, and acknowledgement was received from AKC. Assisted Kathi Jo Zornes by sending fall newsletter to members by e-mail. Annual meeting notice with slate for officers and board was sent e-mail and snail mail to all members. The list of officers, board, and current committee chairs is ready to be submitted to AKC as required provided there are no anticipated changes.

Training: John Ayotte said he knows three people interested in training class. The building is available for Monday night classes. We need to have enough in class to pay for the building with club subsidizing a small percentage of the cost. We need to be more visible to compete with other programs. Newspaper advertising has proven costly and ineffective. Decision was to use our Facebook page and website and advertise on Craig's list. John Ayotte will prepare a flyer for members to give out to friends, neighbors, and co-workers to spread the word. Registration is scheduled for Monday, October 12 at 7:00 p.m. Suggestion was to wait to see response before reserving the building.

Report Of The President: John Ayotte followed up on the possibility of holding an independent specialty in conjunction with Clermont County Kennel Club at the Roberts Centre in September. They will be holding their shows at the same site and are open to the idea of our holding a specialty there. John will continue to work on this and report back.

Election Of Officers: The slate as presented: president, John Ayotte; vice-president, Jon White; Treasurer, Sue Clark; secretary, Rosemary Booth; board - Teri Ayotte, Roy Clark, Joe LaRosa, Marcy Wright, and Kathi Jo Zornes. There were no nominations from the floor. Teri Ayotte moved the slate be accepted by acclamation and seconded by Annette Severance. Motion passed with officers and board accepted.

The next scheduled date for meeting falls on Wednesday, October 21 the week following the National. Board meeting will be held October 21 at Iacono's.

Annette Severance moved the meeting adjourn. The meeting was adjourned at 8:26 p.m.

**G.S.D.C. OF CENTRAL OHIO, INC. BOARD MEETING  
WEDNESDAY, OCTOBER 21, 2015**

The meeting was called to order at Iacono's Restaurant by president John Ayotte at 7:45 p.m. All officers and board were in attendance.

Minutes of the September 16 membership meeting were read. Joe LaRosa moved minutes be approved, seconded by Teri Ayotte. Motion passed.

Treasurer's Report: Sue Clark gave the report. The current period shows a profit of \$253. There is a loss for the year of \$459. Audit of the books is pending. Rosemary Booth moved the report be approved, seconded by Joe LaRosa. Report was approved.

Training: Annette submitted a written report. There are fifteen enrolled in the class. She has divided training into two classes. Nine people got information through Craig's List and the others through personal contact.

Membership: Marcy Wright reported she has an application and check from Vanessa Ewing.

Newsletter: Kathi Jo Zornes reported that our newsletter won first place in our category at the National. We've now placed first for six years.

Futurity: Sue Clark received instruction from Joan Intersimone. She needs to submit information online no later than December 31, 2015, but preferably much earlier. She asked for John Ayotte's assistance with this. The matter of trophies for the Futurity was discussed. Joe LaRosa moved that rather than soliciting for trophies, the club use funds set aside to pay for them. Motion was seconded by Roy Clark. The motion carried.

Awards: Rosemary Booth stated that awards for titles attained in 2015 will be presented at the club's December party. Request for information will be sent to all member.

Unfinished Business: There was a discussion about cost of conformation training. It was agreed that non-members training their own dogs be charged \$10 per session.

John Ayotte provided information he had regarding holding a specialty show at Roberts Convention Centre concurrently with Claremont County Kennel Club shows in 2016. It appears the date in October conflicts with the German Shepherd National. He understands the Claremont County club will charge \$3 per dog and that we must use their superintendent. Under these conditions, our entries would not cover expenses and there would be a significant loss. He will follow up with the Claremont club and the GSDC Of Greater Cincinnati.

Sue Clark stated that our club's insurance is due. It covers liability for all club events. She was authorized to do so.

New Business: The Christmas party was discussed and date agreed on is Tuesday, December 1 with club to pay \$10 per member. Teri Ayotte was authorized to select a restaurant for the party. There was a discussion about having a hospitality for the futurity. It has worked best to have this immediately following our shows on Sunday. Free coffee and doughnuts can be offered on the morning of the futurity (donations welcome).

Review Of Standing Rules: As voted at September meeting, training fee for 6-week course will be \$75.

Additional Changes: Training fee for additional trainees/dogs same household will be \$25.

Eliminate: Trainee may repeat the 6-week course for a fee of \$45 within the training calendar year or consecutive courses, whichever applies.

Intermediate and advanced obedience and rally training fees: \$75 for 6-week course

Fees for additional trainees/dogs same household will be \$25.

Conformation: Non-members participating in class with their own dogs shall pay \$10 per session.

Next membership meeting is on November 18. Decision was to hold meeting at Iacono's.

Joe LaRosa moved the meeting adjourn. Meeting was adjourned at 8:40 p.m.

Treasurer's Report: Teri Ayotte audited the books. She made some recommendations to make balancing the books more efficient.

Training: Graduation is scheduled Monday, November 23 at 6:00 p.m. Members are encouraged to come and assist. Since it is graduation, there will be no conformation classes that night.

Newsletter: Kathi Jo is working on the winter issue. She needs brags and articles submitted by December 7.

The GSDC Of Greater Cincinnati needs a second judge for their specialty on Saturday, May 28. They contacted Joe LaRosa, and he initially declined but then called and left a message that he would be available for the morning show. That would allow him get back to help with our show preparations. He's not received a reply.

Secretary's Report: Parent club sent dues notice for club along with regional club survey to be completed and form to provide our membership. Those were completed and forwarded to Sue Clark. A check was received from Central Ohio Kennel Club for our supported entry at their November 15 show. Vicki Jordan requests judging suggestions for German shepherd dogs. Houston Clark has been contacted for their November 20, 2016 show. Notices for our Christmas party/awards dinner will be sent through the mail to ensure that all members receive them.

John Ayotte gave updated information regarding an October show in 2016 concurrent with Claremont County Kennel Club. We can superintend our own show if we wish, and if we hold our show outdoors, we won't be charged \$3 per dog. He contacted Roberts Convention Centre to ask what the charge is for use of the fenced outdoor area but has not received a reply. If we and Cincinnati do hold specialties concurrent with Claremont County, our clubs should provide them a list of preferred judges and support entries at their shows.

The next meeting will be a board meeting on Wednesday, January 20. Meeting will be held at Iacono's, Hilliard.

## **News: AKC Public Education Program Revamped**

I am pleased to share an update in the area of Public Education under the direction of Brandi Hunter and Davis Alexis.

With the addition of our Public Education Administrator, Davis, in June, the AKC's Public Education Program has been revamped and renewed. Goals for the program have been created and posted on our website in order to provide clarity and direction to our work. More than 50 resource materials are available to clubs and the public on our website and have been amplified and improved in order to cover a wider variety of topics. We have also increased the number of brochures and flyers available in Spanish in the interest of reaching a larger portion of the population. Additionally, the Canine Ambassador Program, one of our most important tools for change, has been enhanced with the expectation to reach the next generation of dog lovers at an early age.

Furthermore, the Public Education Department and the digital content team will be working together to create a children's microsite on akc.org. With the help of Mari-Beth O'Neill and some of our experienced and enthusiastic Junior Handlers, the site will offer new and exciting dog-themed activities, information and games geared toward a younger audience. Thus far, we have five Junior Handlers that will be writing about their experiences at AKC/Eukanuba National Championship and one Junior Handler will be sharing training videos once a month. Our aim is that the new microsite will teach children responsible dog ownership and foster participation in the world of purebred dogs.

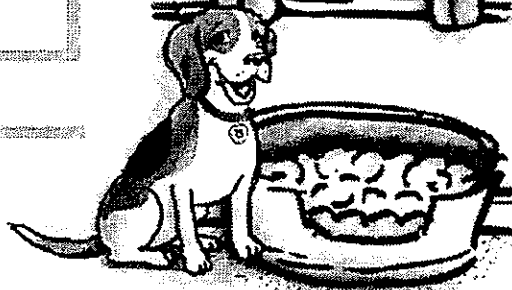

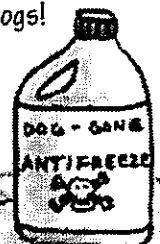

## Health: Should I Worry if my Dog Eats a Ladybug?

A photo showing a bunch of what appears to be ladybugs embedded onto the roof of a dog's mouth has gone viral on social media, warning pet owners about letting their dogs consume these bugs and urging them to inspect their pet's mouth for a similar infestation.

But according to the American Veterinary Medical Association, there's no real reason for concern.

The AVMA explained on Facebook that these bugs are *not* ladybugs, but an invasive species called Asian lady beetles, which caused a problem in a dog who consumed about 16 of them. According to the 2008 abstract, after the dog ate the bugs, they secreted a mucous that caused them to become lodged on the top of the dog's mouth, causing corrosion similar to a chemical burn.

The case mentioned is the only one that's been documented, but a veterinarian from Florida reportedly has seen similar cases in her practice. Still, pet owners would see signs of drowsiness or drooling if their dog was affected with an issue from eating the bugs. In other words, it's not necessary to obsessively check your dog's mouth for beetle infestation unless you see symptoms.

So how common are the invasive species? The AVMA states the following: "Our info is limited, but it appears that—as with many invasive species—the invasive species is expanding and crowding out the native species. But we don't know relative numbers."

## ***NEWS: President Signs Bill Nov 25th Allowing Military Dogs to Retire to U.S.***

On Wednesday evening, President Barack Obama signed the annual defense spending bill that will now allow American military dogs to retire in the U.S. The policy update on military animals was one of many in the \$607-billion 2016 National Defense Authorization Act, according to the *Military Times*.

This law requires that military dogs return to the U.S. to be retired and will give handlers the first chance to acquire the dogs once they are retired, per Voice of America. Before, military dogs were retired overseas and it was extremely difficult for handlers to take the dogs back to the U.S.

## HOME ALONE: SOOTHING YOUR DOG'S STRESS WHILE AWAY

If your dog seems to stress when you leave the house for work, school, or to run to the store for groceries and holiday shopping, there are several things you can do to make him/her feel more relaxed. Here are some quick tips for making good-byes a good experience for your dog:

Leave a television or radio on to keep your dog "company."

Don't make a big deal out of arrivals and departures. Keep greetings and good-byes very calm and emotion-free.

Give your dog something to do when you leave, like a puzzle toy or a Kong with peanut butter inside.

Make sure your dog has plenty of exercise and play and has pottied before you leave.

**Note:** If your dog exhibits behaviors that are more than a few barks or soft whining, he may be experiencing separation anxiety, a behavioral issue that causes extreme distress when away from their owner. Symptoms of separation anxiety include excessive barking, pacing, destructive chewing, soiling in the house, digging and scratching at doors or windows, or trying to escape their crate. If you suspect your dog has separation anxiety, please consult a certified canine behaviorist to have him/her evaluated.

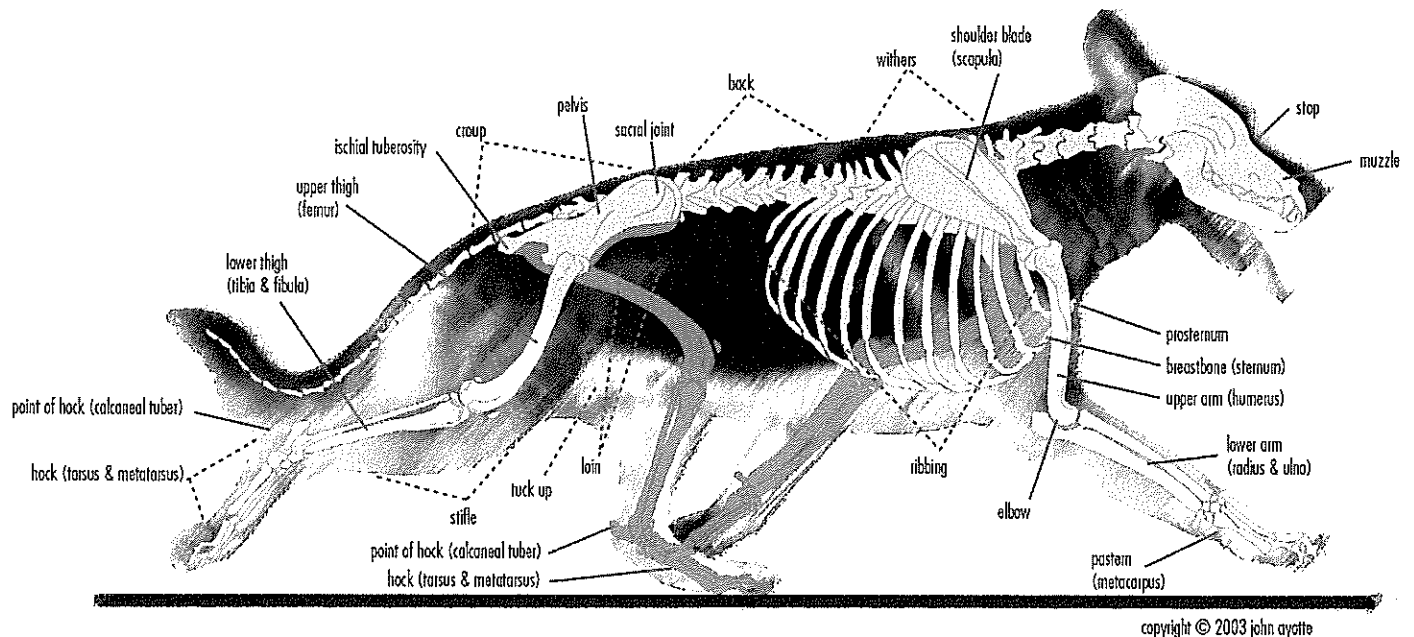
