GSDC OF CENTRAL OHIO, INC., BOARD MEETING WEDNESDAY, JANUARY 20, 2016

The meeting was called to order at 7:45 p.m. by president John Ayotte at Iacono's Restaurant. Due to weather conditions Kathi Jo Zornes was not in attendance but available by phone if needed. Guests present at the meeting were Charlotte LaRosa, Debra Leibengood, and Dave and Charlotte Brugger.

Minutes of the November membership meeting were published in the newsletter so the reading of minutes was dispensed with. A report of the December 1 Christmas party and awards dinner was read.

<u>Treasurer's Report:</u> Sue Clark gave the report. There was a loss of \$279.21 during the period. Joe La-Rosa moved the report be accepted, seconded by Roy Clark. The motion carried.

Membership: Marcy Wright had guests Debra Leibengood and Dave and Charlotte Brugger introduce themselves. Debra has submitted her application for membership.

Specialties: Teri Ayotte reported that class prizes are covered. She is working on ideas for the major breed prizes and entertains suggestions. Question was raised about offering rosettes for classes, but it was decided that is not cost effective. Sue Clark will make sure the misspelling of Columbus gets corrected. Rosemary Booth asked if hiring a food cart for our specialties would be an option since we'll be doing hospitality for futurity. Sue will contact the hotel to confirm they would have no problem with that since restaurant is not open Sunday or Memorial Day. John will investigate possible vendors that might be available and affordable. During the meeting Sue called Rita Bender to ask if Beverly Imbody-Brundige might be available to steward, and Rita reported that Beverly has suffered a health problem and is unlikely to be available. Our specialties were published in the December GERMAN SHEPHERD DOG REVIEW under Calendar Of Events.

<u>Training:</u> Rosemary Booth reported that Annette Severance sent an e-mail that she favors holding training classes either Monday or Tuesday evening starting in March (as discussed at membership meeting). She also wants to offer a rally class as trainees from past classes have expressed interest in that. A target date needs to be established so advertising can be done. Sue will contact Tim Shade to find out what nights the Ganyard Building is available. Since no one listed newspapers as resource for learning about our training, we will not use them. John Ayotte will make a flyer to be distributed at vets' offices, appropriate businesses, and members, and he will post it on our website and Facebook page. Joe LaRosa will put it on Craig's list.

<u>Futurity:</u> Sue Clark received correspondence from national chair Joan Intersimone which included a request for a list of hotels in the area besides our host hotel, a map of the site, and directions from the airport.

<u>President's Report:</u> John gave follow up of his research to hold show concurrently with Claremont County Kennel Club in October. They've moved their date later in October, and weather might not be conducive for outdoor event. We can superintend our own show, but he's been unable to get a price from Roberts Centre for use of grounds. He is also checking open dates earlier in the fall that might be available for specialties (ours and Cincinnati).

Secretary's Report: Club was contacted by Central Ohio Kennel Club to provide trophy information for our supported entry at their April show. Teri Ayotte obtained picture frames, and that information was forwarded to them. Membership cards were brought to the meeting for board members, and the rest will be mailed. Correspondence was received from Royal Canin representative, Tom McDowra, expressing interest in having a concession at our shows and presenting a program for our members. John Ayotte will check to see if a concession at our show would be in conflict with rules since Purina is a sponsor of futurities.

Decision for the February membership meeting was to hold it at Iacono's on Wednesday, February 17.

Joe LaRosa moved the meeting adjourn. Meeting adjourned at 8:30 p.m.

All Breed Obedience Training

basic training - heel, sit, down, stay, and come.

The AKC Agility Department is excited to announce the launch of a new, beginning level agility program called ACT (Agility Course Test). The ACT program officially launches on March 1, 2016.

This program is designed to introduce beginning dogs and handlers to the sport of agility. There are two classes – ACT 1 and ACT2. Clubs and trainers can adopt the ACT classes as the graduation exercise for their training classes to be held at their facility thus providing their students a familiar and comfortable setting. The ring size requirements are small enough that ACT classes can be held in many training facilities across the country. In addition to preparing for these introductory classes, exhibitors will learn to do things such as to enter an AKC event, check-in at the ring, prepare for their run, and handle their dog while under judgment. We hope that clubs and trainers will use these classes as learning experiences.

There are several elements of the ACT program that are different from AKC Agility Trials.

Eligibility to enter: This program is for dogs that do not have an AKC Agility title at the Novice level or higher. Dogs may enter ACT2 without having an ACT1 title. Dogs that are not registered/listed with the AKC may participate and their performance will be recorded under a temporary recording number. Owners will receive a letter from the AKC explaining how they can register their dogs. Application to be listed as a Canine Partner may be accepted at the test and submitted with the results.

Judges/Evaluators: All AKC agility judges may judge the ACT classes. In addition we will be setting up a system for trainers and experienced participants to become ACT evaluators. Evaluators may judge ACT classes. There will be an application, online test and nominal fee to become an evaluator. More information about becoming an ACT evaluator will be available within the next couple of weeks.

Holding ACT events: Any AKC agility judge/ACT evaluator may hold a stand-alone ACT event. The event does not have to be held by an AKC licensed club. AKC agility clubs may hold ACT events in conjunction with their trials if they desire.

Jump Heights: No jump height card is required to enter an ACT class. Handlers are encouraged to have their dogs jump at the appropriate height that will help them prepare for AKC Agility trials.

Event Applications: Clubs or judges/evaluators do not need to file an application for ACT events; there will be no application fee. A \$5.00 per entry recording fee for all dogs entered will be submitted with the results.

Courses: Evaluators and judges will need to submit their courses for review; however, courses may be reused, which we encourage for ease of administration.

Titles: Dogs must receive two passing scores to earn each of the ACT titles. Dogs are required to be fully registered/listed in order to be awarded a title.



STATEMENT OF PURPOSE

This Breeders Code serves as a guideline for a minimum standard of excellence in the ownership, breeding and sales of the German Shepherd Dog. To that end, I hereby pledge to:

HEALTH

- I. Maintain the highest possible standards of health, cleanliness and care in my kennel. This includes, but is not limited to proper veterinary care, regular contact with people and exposure to the outside world for proper socialization of all my dogs.
- II. Urge all buyers to have a puppy or adult dog sold by me, examined by a licensed veterinarian within 72 hours of receipt. The buyer will pay for the examination.
- III. Deliver or ship only puppies or adult dogs of sound health and temperament. Where the buyer or his authorized representative did not personally see and choose said dog, a period of 48 hours is granted to advise of the final decision and an additional 48 hours is provided if the dog is to be returned.

BREEDING

- I. Encourage bitch owners to breed only if they have facilities, time and resources to adequately care for a litter and upon strong evidence of the possibility of finding suitable homes for the resultant litter.
- **II.** Refuse stud service to any bitch I consider in poor health, physically or mentally unsound, or lacking the necessary breed characteristics as set forth in the German Shepherd Dog standard.

Before or at the time of breeding, an exchange of pedigrees and hip and elbow X-ray information must be made.

- III. Allow one repeat service where a bitch has failed to conceive after being bred to one of my studs, if the stud is still in good health and available, and at such time and place as mutually agreed upon by the owner of the bitch and myself.
- **IV.** Breed my own bitches only when I have a definite goal for improvement of the breed in mind, never permitting them to produce three consecutive litters unless breeding consecutive litters is recommended by a veterinarian. I fully understand that I am responsible for keeping and/or finding suitable homes for the resultant puppies.


SALES

- I. Use a sales contract or written agreement in any sale or purchase involving a dog. The sales contract offered by the German Shepherd Dog Club of America, or one similar to it, which covers guarantees and agreements must be used with a signed copy to each party involved.
- II. Refuse to sell or recommend breeders who do not conform to the ideals and obligations expressed in this Code and refuse all sales to dog wholesalers and retailers.
- **III.** Provide buyers of my German Shepherd Dogs with a four-generation pedigree, complete health records, accurate breeding, OFA and registration records, except that registration papers may be withheld or limited in the case of a dog who the parties have agreed in writing will not be bred, until it has been spayed/neutered as evidenced by veterinary confirmation.
- IV. Provide a copy of the German Shepherd Dog Standard to accompany any puppy or adult dog sold by me.
- V. To encourage and invite the new owners of any dog sold by me to attend some type of training class and to join in becoming guardians of the Breed by participating in local dog club activities, educational programs, a regional German Shepherd Dog club and/or the German Shepherd Dog Club of America.
- **VI.** Assure puppy buyers that if at any time the buyer has to place the dog, the breeder must be notified and given the opportunity to assist the buyer in placing the dog.



United Kennel Club Launches New Program-SPOT Testing

The SPOT test is, first and foremost, an evaluation of a dog's ability to handle common, everyday situations, and the owner's ability to control and respond to their dog appropriately in a variety of situations. The mental image that each dog should be compared to when evaluating is that of a polite, relaxed and happy dog, with a relaxed owner who is confident in their ability to control and interact with the dog in a natural everyday way. The SPOT test was designed and created for all dog owners, new and experienced alike. The founding principle of this test is to teach and promote responsible dog ownership. It is NOT intended to be an obedience trial. Not all dogs will be perfect, and some owners may be inexperienced; it is essential that whether they do really well or need more training on a certain step in the test, that you as the Evaluator communicate the importance of responsible dog ownership, and that a well behaved dog is not only a happy dog, but one that will be accepted in a community. The SPOT program is open to all dogs, purebred and mixed breeds. Dogs do not need to be UKC registered or have any UKC listing number in order to participate. The test consists of 10 stations. There are four possible rankings for each station; you will find the minimum requirements for each ranking following the station description. As a SPOT Evaluator, you must rate all dogs to the same standard, regardless of age, breed, or sex. The rating categories are Outstanding, Super, Good, and Needs More Practice. Any dog who earns at least one ranking of "Needs More Practice"at any of the stations will not be considered as having passed the test and must re-take it at a later date. If a dog receives at least a "Good" ranking on every station, the dog will have been considered to have passed the test and the owner can then order an official SPOT certificate from the United Kennel Club. Owners/handlers of dogs taking the SPOT test can talk to their dogs throughout the test and they can praise and touch their dogs at any time. If owners/handlers appear apprehensive or unsure, please take the opportunity to remind them of this and try to encourage them to reassure their dog with praise and petting. Owners may not correct their dogs at any time during the test. The dog may need multiple commands and extensive persuasion from the owner to complete the desired station, but owners may not scold or give leash corrections during the test. Commands and verbal communication to the dog should never be harsh or intimidating. The owner may touch the dog at any time, but may not physically maneuver or force the dog into any position. Food/treats or toys used as a motivational item may not be used during the


