# THE GSDC OF CENTRAL OHIO, INC. BOARD MEETING THURSDAY, JUNE 22, 2017

The meeting was held at The Rusty Bucket, Hilliard. This followed a dinner for all members in lieu of a summer picnic. Officers and Board present were John Ayotte, Sue Clark, Rosemary Booth. Teri Avotte. Rov Clark, Charlotte LaRosa, and Marcy Wright. Members attending were Jeff Pyle, Travis Scarlett, Joyce Willis, Marcy Wright, and Niki Herd.

Since minutes were published in the newsletter, they were dispensed with. President John Ayotte stated this was to be an informal meeting to discuss the matter of show site which was brought up at the May membership meeting.

Secretary's Report: Notices of the July board meeting social event were sent either e-mail or mailed to all members. Newsletter was forwarded to members. Judges in order of preference were contacted. Kathy Potter is unavailable. Charles Mardecz accepted and will judge morning event. Bobbie Kindy also agreed to judge. Contracts and letters were mailed along with stamped envelope to return signed contract. Our 2017 shows have closed out by AKC, and we can apply for 2018

Treasurer's Report: Sue Clark gave the report. The specialties showed a profit of approximately \$435. Considering this was a non-futurity year and two handlers were at a west coast futurity. that is respectable. In her report, Sue stated that she received a letter from Kathi Jo in behalf of Brandon. He felt it was a positive experience and has ideas on how to fine-tune the concession. However, he was asked to have doughnuts, but since the club also brought doughnuts for workers, it was an unnecessary expense as they did not sell. Everyone agreed Brandon did an outstanding job. Charlotte LaRosa moved that Sue write a thank you letter and send a check for \$25 to cover the expense of the doughnuts. Motion was seconded by Joyce Willis. The motion carried.

Training: Members have been meeting every Tuesday to work their dogs outside at the Franklin County Fairgrounds. However the fair will start in mid-July, and grounds will then be unavailable. Joe and Charlotte LaRosa offered their place during the period the fairgrounds are not available.

President's Report: John reported that the Cincinnati club contacted him regarding show sites. The conformation group of the Cincinnati club are moving the breed classes to a separate site from obedience and rally and would like to work with our club to find a suitable site that can either be used by both clubs or that will be less remote and more convenient for exhibitors. They also have contacted parent club president, Carmen Battaglia, who is an AKC representative, to petition for exception of the rule that prevents clubs from a one-time change of site.. We do not have any figures for the Roberts Arena outdoor area. Tom McDowra has changed positions at Royal Canin, but he has given John the contact for our region to inquire about the Roberts site. John will also check hotel sites at the Jefferson Mall exit to find out if any have sufficient grounds for a show. There is also a Travelodge in Grove City west side of I-71 that has a grassy area behind it. Another idea would be to try to work out an agreement with Trumbull County Kennel Club to each hold breed classes for German shepherd dogs. However it is likely that agreement could be terminated by them at a future date. We need to hold a meeting in July to discuss this issue, and he would like to hold the meeting on a Tuesday to allow members to work their dogs beforehand. Since the fair is in progress on July 18 (third Tuesday), Joe and Charlotte LaRosa have offered to have the meeting at their place.

John stated we need to set dates/places for following meetings. A board meeting will be scheduled on August 16 at Iacono's. The September (annual) meeting is on the 20th, and will be at Ia-

Charlotte LaRosa moved the meeting adjourn. Meeting adjourned at 9:15 p.m.

# GSDC OF CENTRAL OHIO, INC. MEETING **TUESDAY, JULY 18, 2017**

The meeting was called to order at 8:15 p.m. at Joe and Charlotte LaRosa's home. Fifteen members were in attendance.

Minutes of the June board meeting were read. Pat Pillitteri moved minutes be approved, seconded by Joyce Willis. Minutes were approved.

Treasurer's Report: Sue Clark gave the report. There is a loss for the period. All payments have been made and money received from our May specialties, and the club realized a small profit. Jeff Pyle moved the report be accepted, seconded by Charles Gregory. The motion passed.

Secretary's Report: Received Charles Mardecz' signed contract. Contract from Bobbie Kindy was not received. E-mail to Bobbie revealed address listed in AKC judges' directory was incorrect so another contract was sent to her. E-mailed Tahisa Ashe, AKC Events contact, regarding arranging with Trumbull County Kennel Club to co-exist for German shepherd dog breed classes. In the event that we moved outside the 200-mile perimeter, it would be up to them since they would own the date. She mentioned that The GSDC Of Greater Cincinnati president also contacted her regarding options.

<u>President's Report:</u> John Ayotte checked out Roberts Arena, hotels at Jeffersonville outlet mall exit, Country Hearth Hotel in Washington Courthouse, Fayetteville County Fairgrounds in Washington Courthouse, and the Travelodge in Grove City. Roberts Arena is more than two hundred miles from Trumbull County KC show site. All others measure under two hundred miles. The price stated by Roberts is \$800 a day, but that can likely be negotiated. Travelodge has a corporate policy of no dogs in rooms. There was a discussion about pros and cons of sites, and Steve White raised the question of checking on Clark County Fairgrounds, Springfield. John invited members to go with him to look at the sites. He will be in contact with the Cincinnati president, Joyce Daugherty.

New Business: Charlotte Brugger raised a question on whom to contact regarding parent club sponsorship of our breed in the upcoming AKC Agility Invitational. Last year they were the only breed club not awarding a prize for their breed's highest scoring dog. Recommendation was for numerous agility competitors to petition president Carmen Battaglia regarding award for high scoring German shepherd.

A nominating committee needs to be chosen. Charles Gregory volunteered.

The August is a board meeting. It will be at Iacono's on Wednesday, August 16, 7:30 p.m. Pat Pillitteri moved meeting be adjourned. Meeting adjourned at 9:25 p.m.

Board Meeting Weds. Aug. 16, 2017 Iacono's Restaurant-Hilliard

Attendance: All Board members present except White, Booth & R. Clark; Guests were Gregory, Willis & J. LaRosa Total Present: 9

The meeting was called to order at 7:45pm by President John Ayotte.

The minutes of the last meeting was read by Kathi Jo Zornes in Rosemary Booth's stead since she underwent shoulder replacement surgery and is unable to drive currently. Charlotta LaRosa made the motion to accept the reading of the minutes as printed. 2nded by Sue Clark. All present approved-motion carried.

# Secretary's Report:

- 1. The Club received Bobbie Kindy's signed contract.
- 2. Info was sent to Charles Gregory for nominating committee.
- 3. Rec'd forms from the AKC to complete after election in September.
- 4. Paperwork for our 2018 show site has not yet been submitted to AKC Contact Tahisa Ashe since a decision on a show site has not been remedied [site map will be needed].

Charlotte LaRosa made the motion to accept the Secretary's Report. Seconded by Sue Clark. All present approved-motion carried.

<u>Treasurer's Report:</u> Sue Clark reported no income for this past month, and expenses were minimal. Expenses totaled \$130.34. The treasurer's report was submitted with no corrections and filed for audit.

<u>President's Report:</u> Ayotte double checked with Rick of H&R Block-we won't have any change of ID #'s -we just need to promote the program again this year. Tax season begins in October; H&R Block donation last year to the Club was \$1,580; we have to gain new people signing up [no payout for existing clients] to get a donation again.

Ayotte mentioned that Kathi Jo was correct concerning Robert's Rules of Order stating that treasure reports are not voted upon, but rather, filed for annual audit.

<u>Newsletter Report:</u> The next issue will be out in September; Kathi Jo asked everyone present for brags, litter announcements, etc to be provided for putting into the next issue by Sept 7th. Our newsletter is up for GSDCA National newsletter competition judging in October.

## **Unfinished Business:**

Show Site Issue Update: Roberts Arena has lowered their quoted price to from \$800 to \$200; Ayotte petitioned Royal Canin to assist. RC is willing to donate \$1,000 if we use their site: \$600 towards the Roberts Arena rental, and \$400 to go towards Club expenses to host the show there. Greater Cincinnati Club President Daughtery & Ayotte went & visited Roberts Arena again and to see Washington CH hotels. There are logistical issues with the Arena's outside grounds; Ayotte told RC they would need to cover parking area and build a couple of bridges over drainage areas.

Issues with Washington CH hotels: 1)There's no way to drive to the grassy area, and 2) Greater Cincinnati Club people refuse to go anywhere in Washington CH.

Ayotte went on to explain that if we move out of the Trumball Co area, we won't have any negotiating factors to work with.

Ayotte also visited Deer Creek lodge & park and said it's a very large area. There's the issue that park issues must deal with Park Mngmt, and Lodge issues are handled by Lodge Mngmt. The park charges a \$40 nominal fee that is often waived by the State Park Officials. It's out in the boonies but has a restaurant, camping places, a lodge, cabins to rent, etc.

[The lady who waits on our tables at Iacono's visits Deer Creek camping often and said it's an extremely busy place and that, during a holiday, that people would have to make advanced

reservations 6-8 **months** ahead of time just to make sure they got a spot. That definitely throws a big wrench into the site's consideration]

Ayotte went on to suggest for the Club to look for other parks south of Columbus & report back to him; Gantz Park might be considerable for just 1 year.

Discussion was made considering Hampton Inn on Cemetery Rd, Scioto Downs, the New Jefferson Mall, hotels near the airport, Franklin Co Fairgrounds & other locations but there seems to be complications with all. The idea of contacting a school was also mentioned.

Charlotte LaRosa asked about the surety of Roberts Arena being Greater Cincinnati's Futurity Show site in 2018; Ayotte said he's pretty sure because Greater Cincinnati doesn't seem to have many options to consider.

The overall consensus of Club members present was that we look for a show site closer to Roberts Arena, but still stay within our 200 mile requirement; if such a place can't be found, then our original show site at Magnuson Grand Columbus North is acceptable.

Our AKC paperwork on submitting a 2018 show site location is due to be completed by the end of September/early October.

Teri Ayotte made the motion that we table the issue of selecting a 2018 show site for further discussion at our September meeting. 2<sup>nd</sup> by Joe LaRosa. All present approved-motion carried.

2018 Nominations Charles Gregory, Nominating Committee for 2018 Officers & Board Gregory reported that he didn't receive any communication from Booth.

Agility Trials: Marcy Wright got an email from Susan Crank checking to see if the Club wished to add a 2<sup>nd</sup> agility trial date for April 13-15 or June 30-July 1<sup>st</sup>. Ayotte said we need to take one step at a time and that the Club is not ready to commit to sponsor another date at this time.

*Training:* Teri Ayotte brought up training: it's not yet time to be moved indoors Kathi Jo Zornes offered, as a TDI Therapy Dog & CGC Evaluator, to schedule a date for CGC/CGCA, Therapy Dog and/or AKC Trick Dog Testing that the Club would wish to host as part of our educational requirements.

Sue Clark said she would talk to the Fairgrounds to see if they will be flexible on the cost of building rental this fall when it gets cooler.

# **GSD HEALTH: GSDs & the MDR1 Factor**

MDR1, which stands for Multi Drug Resistance 1, is a common mutation found in many herding breeds, some sighthound breeds and occasionally in several other breeds. It is commonly referred to as "ivermectin sensitivity," although this is a misnomer because there are around 15 other drugs that can adversely affect a dog with this mutation. The MDR1 gene codes for a molecular drug transport pump, so mutations in this gene impair a dog's ability to control the absorption, distribution and elimination of certain drugs from their body. This is especially important for the nervous system, which is very sensitive.

Breeds that can be affected by the MDR1 mutation are: Australian Shepherd, Border Collie, Collie, English Shepherd, *German Shepherd*, Long-haired Whippet, McNab, Old English Sheepdog, Shetland Sheepdog, and Silken Windhound.

Dogs with mutations in their MDR1 gene will appear normal (you cannot physically look at a dog and determine whether or not they are MDR1 affected), but even one mutated copy of the gene can cause them to have adverse reactions to certain drugs, even when given at standard doses, at any time in their life. Dogs with two copies of the mutation will have the most severe reactions and, in some cases, may die of what appears to be a drug overdose.

Drugs to avoid with MDR1 Dogs: The tranquilizer acepromazine; a pain medication called butorphanol; the anti-cancer drugs doxorubicin, vinblastine and vincristine; the antibiotics erythromycin and rifampin; anti-parasitic drugs such as ivermectin (in high doses), milbemycin, moxidectin and selamectin, the anti-diarrheal drug loperamide (Imodium), Ondansetron, Domperidone, Paclitaxel, Mitoxantrone, Etoposide, Rifampicin, Quinidine, and Morphine.

As a Breeder/Exhibitor within the GSD breed for almost 20 years, I have personally witnessed more cases of GSDs being diagnosed with the MDR1 mutation with longer coats than plush or stock coat varieties. While this may or may not be reliable, that is only my personal observance.

If you wish to know whether or not your beloved GSD has the MDR1 mutation to be on the safe side, you can order reasonably priced DNA kits that get the results to you quickly via email. The best price for genetic testing that we have found is thru GenSol Diagnostics, who runs specials often where breeders/exhibitors can order 5+ DNA tests for \$25/each. The test is simple to perform by collecting some cheek cells on a swab and sending it back to the lab for processing. Their results are accepted by the OFA, so any results obtained thru GenSol genetic testing can be sent in for official OFA records with the proper form and \$15 OFA recording fee per test.

## TRAINING: HOW TO STOP A BAD HABIT

Investigate the cause of the behavior -- look for its hidden reward. Dogs always do what works; your GSD is being rewarded in some way for their bad habits. A dog that counter-surfs, for example, is rewarded by the scraps of food they find. If you look hard enough, you can find a reason for the bad habit.

Remove the reward, if possible. If your dog digs through the trash, for instance, move the trash can up high on a shelf or place a lid on it. If they bark out the window, shut the blinds. If they jumps on visitors, ask your visitors to ignore him until he sits politely. *Consistency* is key here; everyone who interacts with the dog **must** maintain the same set of rules.

Provide your German shepherd with at least 45 minutes of exercise every day. They are bred to work hard and solve problems, and if left with nothing to do they will often find their own challenges -- which may not be desirable.

Enroll your German Shepherd Dog in a group training class to provide them with an outlet for his energy and pent-up frustrations. They'll also benefit from the socialization-our Club gets together once every week for this purpose!

Give your German shepherd small treats when you catch them doing something right. The more you let them know which behaviors you like, the better their conduct will become. You can also reward them with affection in lieu of food.


