Even though I started 2013 with a heavy heart, the year has been an exciting one for Blade and me!!! We started showing in January to accumulate the 100 points (points are earned by your score/higher score = more points) necessary to earn a UKC/U.R.O.C. (United Rally Obedience Championship). We showed at 8 trials. 4 in January and 4 in March. Blade accomplished his U.R.O.C. in March. Of the 8 trials, he took "High in Trial" 4 times!!! With entries in the 40's and 50's.....that was quite an honor. Blade may be large (~110#) but we are really fast!!! We can complete a course of 16 signs in slightly over a minute!!!!!! I don't know who has been smiling down on me, but Jax and Blade, although totally different personalities, are/were spectacular partners!!!! I am blessed to have had Jax in my life and to have Blade in my life:-) Bev Mills

King's Da Bomb, NA (better known as Sizzle and the NA was for her Novice Agility title) earned her second agility title on April 28, 2013 with flying colors. Sizzle earned her Open Standard title. These are the courses that include all of the different types of agility equipment. The dogs have to qualify on 3 different days, only certain errors are allowed and all has to be accomplished in a specified amount of time. Sizzle trialed on Friday and Sunday, qualified both days with a 100 on Friday and was the only dog to qualify in all jump heights combined. She got a 95 (made only 1 error - no dog earned a 100) on Sunday with only 3 other dogs in all the jump heights combined qualifying. Both days Sizzle placed first and was at least 26 seconds under the allotted

time. The girl is border collie fast! She will now be competing at the next level which is the Excellent level. I am so proud of her. She is coming on fast and strong and, more importantly, she really loves the sport and I love doing it with her. Sizzle is now known as King's Da Bomb, OA.

King's Da Bomb, OA exploded once again this past weekend. On Sunday, May 5, 2013 Sizzle earned her Novice Jumpers With Weaves agility title. There were only two dogs (the other dog was a 16" jump height dog) out of all the jump heights that managed a qualifying score. So, Sizzle earned a qualifying score, a first place and her title. The girl is on fire! Our teamwork is really coming together. On to Open in jumpers now and she is in Excellent in standard.

**FYI:** The standard courses have all of the agility obstacles and the jumpers with weaves courses are as the name implies - jumps, weaves and may also include tunnels.

## For New Puppy Owners: Show Off *Your* AKC S.T.A.R. GSD Puppy!

The AKC created the S.T.A.R. Puppy program specifically with puppies under 1 year of age in mind. The S.T.A.R. acronym stands for Socialization, Training, Activity and Responsibility. Under the advisership of an approved AKC Canine Good Citizen Evaluator, a minimum of six classes are held, typically for around 45 minutes once a week. Puppy owners can come together to socialize their puppies with other puppies, play games, receive basic obedience instruction, and learn about responsible puppy ownership, including dealing with issues such as dominance, crate training, teaching 'off' and several other things that provides a good foundation for a Canine Good Citizen down the road. Puppies who pass AKC S.T.A.R. Puppy evaluation at the end of class can send in their AKC paperwork and receive a framable certificate and a keepsake S.T.A.R. Puppy medallion for their new achievement!

The following is the AKC S.T.A.R. Puppy class plan used by our very own club member & Canine Good Citizen Evaluator Kathi Jo Zornes:

### WEEK 1:

Written hand-outs on: Crate training, teaching 'settle' & AKC brochure on the S.T.A.R. Puppy program

- #1 - Shows proof that puppy is in care of a vet (shot records)

\* - Classes **can** be made up if the Evaluator so chooses, but the owner should be present for as many as possible.

It is important to attend all classes because most of the exercises are actually observed and evaluated **during** the course of the weekly classes, not just at the end like the Canine Good Citizen program. Whereas you do not have to go thru any prior classes in order to participate in Canine Good Citizen testing, its required by the AKC for a puppy owner and their puppy to attend classes in order to be AKC S.T.A.R. Puppy evaluated. This is to help ensure the great importance of early socialization isn't overlooked by new first-time puppy owners.

Once the AKC S.T.A.R. Puppy evaluation is passed, the owner gets an official form signed from the CGC Evaluator that they can send to the AKC along with a fee. The proud puppy graduates will then receive a frameable AKC S.T.A.R. Puppy achievement certificate and a medallion from the AKC. This, like the CGC, is an award, **not** an official title. It's a GREAT way to start a puppy off on its way for a promising career in the show ring and in its local community!

### AKC National Owner Handled Series Tips

Many clubs are offering this Series at their events and exhibitors are excited to enter the competition. Clubs offering the AKC National Owner Handled Series (NOHS) should be sure to notify their judges of the inclusion of this competition in their event. It is also imperative that clubs work with their stewards to educate them on how to administer the Series and work with the superintendent to avoid Group ring conflicts.

#### Judging

Information on the judging procedure for the Series can be found on the AKC NOHS webpage. This page also includes a helpful chart for which dog(s) are eligible based on the regular class winners. It is preferred that judges be approved for at least one group (not necessarily the AKC NOHS Group they will judge). If no group judges on the existing panel are available, club can use judges with less than a group.

#### Stewarding

The show chair (along with the AKC Field Representative, if in attendance) should conduct a briefing with all stewards to remind them of the inclusion of the Series and answer any questions that may come up. Stewards should focus on the dogs eligible to compete (those with

### Seminars

Are you a new event committee member? Have you been working with the committee for some time but still have questions? Have you been the show chair for many years but aren't sure of all the new AKC policies? If you answered yes to any of these questions the AKC Show Committee Seminar is for you!

These seminars cover topics such as AKC paperwork, superintendent & judges selection, preparing a premium list, event hearings, new AKC rules, regulations, and policies and much more! A knowledgeable and experienced AKC representative facilitates the seminar and is available to answer any of your questions about putting on the best event you can.

an asterisks (\*) next to their name) not on the dogs that can win. The judge will decide which dog is the best dog and therefore the winner.

### Superintendents/Event Secretary

Clubs and Show Chairs should work with their superintendent or event secretary to avoid conflicts with the AKC National Owner Handled Series Groups and the regular Groups. One of the most frequent complaints from exhibitors is that the groups overlap and they must make a choice. AKC recommends scheduling the NOHS Group judging to begin at least thirty (30) minutes prior to regular Group judging to avoid such conflicts.

### Friendly Reminders

In the rush to complete event registrations, submit applications, judging panels, and show results, or deal with the multitude of issues that are involved with hosting an event, it is easy to forget a few things. Below are some friendly reminders regarding some common misunderstandings or misconceptions that the Event Operations department sees on a regular basis.

- Effective July 1, 2013 an asterisk must be next to each assignment for a provisional judge. This must be done in the premium list, judging program, and catalog.
- *Clubs are required to publish the following statement in their premium list: "Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."*
- In addition to the above statements, club should include any specific local or state health requirements, for example, proof of rabies.
- *It is recommended that the ribbon color(s) for Best in Show and Reserve Best In Show are not the same to avoid confusion by exhibitors, judges, and stewards.*
- Clubs must comply with the Americans with Disabilities ("ADA") state and local laws.
- Effective immediately the Best in Show judge shall first announce Reserve Best in Show followed by Best in Show.

At their October 2011 meeting the AKC Board of Directors adopted the following policy:

1. A club holding back-to-back-shows, clubs holding consecutive days of AKC events, or different clubs in a cluster may use a combined catalog if the same secretary/superintendent is used.
2. Event Catalogs may not go on sale until one hour prior to judging the first AKC event.
3. When a combined catalog is used, a separate copy with all placements and absences marked must be sent to AKC for each of the events.

This means that clubs holding all-breed or specialty events on consecutive days (Friday – Saturday) or different clubs in a cluster in addition to National Specialties can combine their catalogs. The most important part of bullet #1 is that the **same secretary or superintendent is being used** for each event within the combined catalog. For example, if a specialty club is offering Agility, Obedience, Rally, and Conformation but are using a licensed secretary for the Agility and a superintendent for the Obedience, Rally, and Conformation the four events cannot be contained in the same catalog. The Agility must have its own catalog. The Obedience, Rally, and Conformation can be in the same catalog if they are held on consecutive days.
